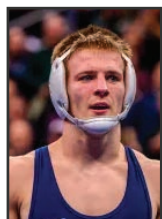

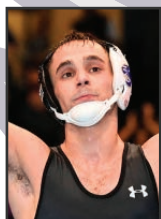
CAMP MISSION STATEMENT
